AMENDMENT TO THE DECLARATION

Also known as "SHORT TERM RENTALS" shall mean the renting of a residential dwelling unit for a period shorter than thirty (30) days.

Under Article V, USAGE RESTRICTIONS add the following: VACATION RENTALS BY OWNER. Vacation Rentals By Owner as defined under amended article 1, DEFINITIONS, are a prohibited use within Glacier Village Greens Subdivision Phase V.

Each and every other provision of the Covenants as recorded among the land records of Flathead County, Montana, shall remain in full force and effect.
